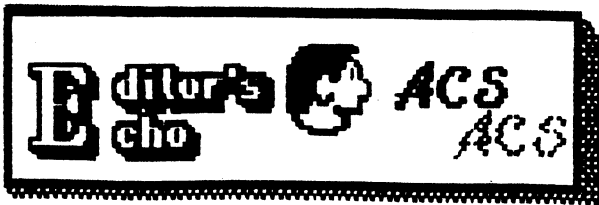

Not too long ago some football buddies and I were talking over the upcoming season. Stats were bandied about and the usual macho chiding/back slapping/arm punching were celebrated.

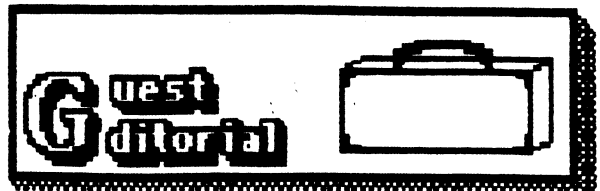

Removable Hard Drives for the Coco!

Deluxe hard drive systems for the Color Computer are hard to find these days. Most of the interfaces available typically are out of date and will not support the current models of hard drives such as IDE, Enhanced IDE, SCSI-2, and whatever else the Intel Generation makes standard next week. However, there is a relatively new hard drive unit on the market that looks as if it were made for the CoCo: The SyQuest EZ135.

SyQuest has been making hard drives for ages. They are famous for their removable drives where the actual "drive platter" comes out, similar to a large capacity floppy. The EZ135 is a 135 megabyte removeable SCSI hard drive. Unlike the similar Iomega ZIP drive, the EZ doesn't require hardware parity and has normal SCSI connectors which makes it work perfectly on a CoCo. SCSI interface such as Disto's or

Ken-Ton. And it works very well.

The unit currently has a retail price of \$120. This is a great reduction over the original \$200+ price it was at just a month ago. The EZ135 unit is very small and has it's own external power supply. Unlike most hard drive cases, this one is very quiet and doesn't even need a fan. On the rear of the unit are two full size 50 pin SCSI connectors and a switch to toggle the ID of the drive (0-7). Included is one 135 megabyte EZ disk (additional ones are about \$20 each), a DB25 to SCSI cable (not useful for the CoCo), and a SCSI terminator (no jumpers to set if this is the last or only SCSI drive hooked to your interface!).

Upon plugging up to the CoCo, I ran a few speed tests to compare it against my 250 meg Quantum hard drive. The non-removeable Quantum (a slimline, 3.5" model) does a 1 megabyte read in about 26 seconds. The EZ135 clocks in at about 31 - a bit slower, but still quite speedy and, most likely, faster than older full-height SCSI and MFM drives many CoCoists are using. The EZ also plugs up to an MM/1 with no problems and reads 1.5 megabytes per second on a non-accelerated unit (versus 90k a second for a ZIP drive on the same machine). Not bad at all.

Since the EZ is a 512-byte sector drive, Matt Thompson's SCISISYS drivers are required to get the most storage out of it. RGB-DOS also likes the EZ just fine. I have one disk setup with 256 RS-DOS "drives" and

52 megabytes for OS-9. A second disk is setup entirely for OS-9: a full 135 megs. If that's not enough, I just buy more EZ disks. It's a great deal.

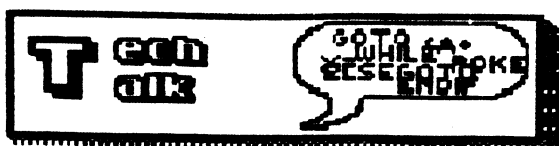
I cannot stress how great this drive is. Virtually any large computer store (Best Buy, CompUSA) should also have it in stock. A two year warranty is included, and the fact that it's standard SCSI means this unit can be used on the CoCo, MM/1, a PC with SCSI, Macintosh, Atari ST, Amiga, etc. I am currently sharing my EZ between my CoCo and MM/1 (a different disk for each, of course), though I plan to buy a second unit real soon so I will have one for each, or can hook them both to the same machine and do 135 megabyte backups.

If you have a CoCo SCSI hard drive controller, this is your best bet at upgrading. The EZ135 is small, quiet, affordable, and pretty neat looking as well. And, unlike many other items hooked to your computer, this one is current, new, and state of the art.

I hope to have some RGB-DOS utilities available soon to simplify customizing the OS-9 offset for the ROM, as well as other things of interest. Keep the torch lit, and let the CoCo shine on!
